Public Employee Retirement System of Idaho (PERSI)

- Mandatory defined benefit plan (Base Plan)
- Voluntary 401(k) plan (Choice Plan)
 - Began in 2001, when the Base Plan was overfunded
 - Grandfathered an existing 401(k) plan
- 800+ public employers in PERSI
- "Simple, transparent, focused" philosophy



PERSI Choice 401(k) Plan

- \$834 million in plan assets
- 39,200 participants with balances
- 15 investment fund options
 - Default fund is a mirror image of the Base Plan fund ("Total Return Fund")
 - Revenue sharing returned to participants

 - Replaced T. Rowe Price Small Cap Stock Fund (OTCFX)
- Brandes International Equity Fund Class R6 (BIERX)



United-sponsored retirement plans

- Approximately \$21B of invested assets
 - 82% in defined contribution plans
 - 18% in defined benefit plans
- United sponsors two primary DC plan environments
 - Approximately 80,000 active participants
 - Combination of predominately actively managed white labeled funds and index funds
 - Custom and off-the-shelf target-date funds as QDIA
 - Invests primarily in collective investment trusts and separately managed accounts with some mutual funds


Manager fees and additional considerations for investment vehicle or share class selection

- Size of assets under management for a strategy – Re-enrollment / QDIA
- Separate account considerations and complexities
 Additional fees, registrations, disclosures
- Revenue-sharing
 - Record keeper capabilities
